## Question posed to the Court by President Mohammad

#### **Summary of Discussion**

In response to the question of how an interim Speaker should be elected – The President shall appoint an interim Speaker to serve until May 1<sup>st</sup> 2014, who must be confirmed by the senate by recorded vote at the next Senate Meeting. Student Court rejected the proposal to allow voting for interim Speaker by email. Student Court also advised Student Government to address the issue of the proper procedure to elect an interim Speaker should the current Speaker resign or for any other reason be unable to fulfill their duties.
